The Information Required and how it is implemented

We at GreekBank have a variety of services that require minimal personal information in order to have a member account with us. In order to provide the best of our service we need the ability to collect the following variety of information:

-Information the Member Provides. When you register for a Greekbank Account information such as: name, email, phone number (optional) and account username/password is required. For services regarding "Pay Now," require credit card and debit card account information, which is recorded in our secure servers.

-Log Information. When the person/member access GreekBank our servers will record information when you visit the website. The server logs may include information such as: Internet address, browser type, language and date and time of requests made and web requests. "Cookies," may identify your browser.

-Member Contact. When the person/member contacts GreekBank, we may hold on to those contacts to analyze and improve GreekBank services overall.

-Website Links. GreekBank may show the website links in a presentation that enables us to view if the website links have been followed. This information is to enhance and update the quality of services.

GreekBank overall only uses personal information provided as stated in this Privacy Policy for specific company services. Additionally in such purposes such as:

- Service Development by research, analysis and auditing
- Services provided to our Members/Users; and
- Ensuring the proper functioning of the GreekBank network

The personal information is processed in the United States or America on our servers. We may process personal information to provide for the GreekBank services. Additionally we may process personal information in according to the instruction from member organization and our advertising partners.

Choices Of Information Given

When a person signs up for a particular service that requires some registration, we will as you to provide personal information. If we use the member/users information in a alternative manner than the purpose provided we then will ask for consent prior to the use overall.

If GreekBank proposes to use personal information for any purpose that is not outlines in this Privacy Policy and its notices, we have an opt out clause of personal information for those other purposes. GreekBank will not collect sensitive information other than the ones described in this privacy policy unless consent is obtained.

Sharing of Information

GreekBank only distributes personal information with other individuals/companies outside of GreekBank under the following cases:

We obtain the member/user consent.

- Prevent fraud, security or technical issues.
- Protect harm to property, rights or safety of GreekBank member/users as required by law.

If Greek National LLC or its companies is involved in a acquisition, merger or any form of sale of assets, Greek Bank will provide notice before personal information is transferred and becomes part of a different Privacy Policy.

Security of Information
